Subject: Investment Report for the Month of July 2015

Summary

Attached is the Investment Report for the month of July 2015. As required by the District's Statement of Investment Policy, the Investment Report delineates all investment activity during the month.

Staff Recommendation

Approve the Investment Report for the month of July 2015.

<u>Analysis</u>

This report lists the types of securities held in the District's portfolio, the institutions from which the securities were purchased, maturity dates and interest rates as of July 30, 2015. The District's investments are in compliance with the Statement of Investment Policy adopted by the Board at the June 25, 2015 regular meeting, as well as the California Government Code. The market values in this report were provided by our third party custodian, Pershing, LLC, except for the Local Agency Investment Fund (LAIF). The market value of LAIF was provided by the State Treasurer's Office. It does not represent the value of the underlying securities within the pool, but rather the par or cost amount, which is the amount the District is entitled to withdraw. This reporting practice is consistent with industry standard practices for similar funds.

The weighted average stated rate of return (current yield) for the District's investment portfolio as of July 31, 2015, was 0.938%. The yield to maturity of the portfolio was 0.933%. The District's weighted average interest rate was 61 basis points (0.612%) above the daily effective yield of LAIF, which was 0.32% as of July 31, 2015. The weighted average number of days to maturity for the District's total portfolio was 732 days (2.01)



years). The average duration of the underlying securities in LAIF as of July 31, 2015 was 239 days.

The District's investment portfolio is in compliance with its liquidity limitations, which requires that a minimum of 20.00% of the portfolio must mature within one year. The percentage of the portfolio maturing in less than one year as of July 31, 2015 was 35.39%.

As of July 31, 2015, the District has adequate cash reserves necessary to meet its obligations for the next six months.

Strategic Plan Element & Goal

This item supports achieving Strategic Element No. 7.0, *Finances,* by ensuring the short and long-term fiscal health of the District.

Legal Review

Legal review is not required.

Environmental Review

Subject activity is exempt from the requirements of the California Environmental Quality Act (CEQA) (Public Resources Code Section 21000 et. seq.). Section 15300.4 of CEQA allows an agency while establishing its own procedures "to list those specific activities which fall within each of the exempt classes", and the District has adopted "CEQA Guidelines and Implementing Procedures" that state on page 6, ""Projects" does not include....C. Continuing administrative or maintenance activities."

Financial Review

The portfolio was budgeted to earn an average rate of 0.900% for the year ending June 30, 2016. Through July 31, 2015, the portfolio has earned a weighted average interest rate of 0.938%.


